Caroline Shone (EECA) - On Tuesday the 5th August Minister Watts announced a significant change to the eligibility criteria for Warmer Kiwi Homes. The programme is expanding to include the owner-occupied homes in deciles 5 and 6 on the Census 2023 NZ Deprivation Index, which means there could be up to 300,000 additional homes eligible for insulation grants. Although the budget has not increased, more homes will receive a grant. The changes have been noted by the Trust and there are some opportunities to work with EECA.

7.7 Insurance Renewal

We do not receive amended insurance policies until they have been paid and renewed. There is concern regarding the absence of the amended policy and the removal of the insured person. The Trust has noted this concern.

Marsh Insurance - The endorsement did specifically note cover for the secretary, but the insurer has advised that the policy intention is to cover the Trust and Trustees. However, the insurer has advised that if the Secretary made a mistake in their role in managing the trust, the policy could still respond.

The Secretary is to approach BoardPro to review the agreement and confirm whether we are covered for data security.
